List Required: For safety reasons, we need to know who is in your group! You will need to bring a list with the name of each adult, and the name and age of each child.

Group Visit Fees: \$10 per adult; \$3 per child.

Refunds: To receive a full refund, cancellation must be received 36 hours prior to scheduled visit.

Alcohol: No alcohol is permitted at any time on any Pool or adjacent Weis Ecology Center property. Drinking or being under the influence will result in having to leave the grounds, with no refund.

Other exclusions: **Please be aware that we are unable to accommodate any pets, or amplified music or speech, at our facility.**

Supervision/Staffing: Minimum 1 adult per 10 children; children in shallow section must be supervised at all times.

Water Test: Anyone under 18 must pass a deep water test to swim in the deep water.

Diapers: Anyone who wears a diaper must wear a water proof “swim” diaper.

On the day of your visit, please bring with you:

- ✓ A list of everyone coming that day (as described above), to be given to the Pool Manager or Gatekeeper. We will check off each person’s name as they enter the Pool, then go over Rules & Regulations and Grounds Rules, and then give everyone a guest wrist band which will allow access to the Pool & facilities for the day.
- ✓ Separate plastic bags for garbage and recycling: we have a Carry In/Carry Out policy; you will need to take all your garbage and your recycling with you when you leave.
- ✓ If the Weis recreation field is available, you may bring sports equipment if you like (we do have bases, and ping pong equipment, available for use, and there is a volleyball court on the field).
- ✓ *You may want to bring folding tables (for food) and folding chairs for extra seating.*
- ✓ *If you plan to cook with charcoal: please bring FatWood or other non-chemical fire starter, or use a charcoal chimney with newspaper; we do not allow starter fluid or chemically-treated briquettes.*
